Thank you for sharing the longitude & latitude considered for the highest site elevation of the plot. When the coordinates were marked on Google map, the location indicates the construction road which is at 883.m lvl [based on the local benchmark] - refer to the screenshot below.

KIP had communicated that the location of the highest site elevation on the plot shared by you might have been taken on the grass mound which is 1m [approx.] above the podium level [888.05m lvl]. As communicated to you yesterday, the grass mound is a landscape feature and it is filled with lightweight material on the podium slab & few layers of soil above the lightweight material for growing the grass.

In addition to the above, request to make changes as indicated in the screenshot below.

The site elevation [888.95] indicated in the report can be considered the highest site elevation of the plot. As informed by you, the levels are taken based on the ARP and may not match with the metro levels.
