The undersigned is pleased to accept your rates quoted for the work as detailed in Schedule 'B' attached herewith. You are requested to start the work immediately subject to the terms and conditions as laid down.

**Value of Work : Rs. 25,000.00 + (GST 18%) Rs.4,500.00 = 29,500.00,
Say Rs. 29,500.00**

(Rs. Twenty Nine Thousand Five Hundred Only).

TERMS & CONDITIONS

- 1. Time limit:** The work shall have to be completed within the period of **10 (Ten) Days** from the date of handing over of site or the date of issue of work order, whichever is later, failing which, you shall be liable to pay compensation/penalty @1% per day up to maximum of 10% of the value of the work order.
- 2. Assurance to Bankers:** The request of the agency regarding assurance about payment to any Bank shall not be entertained in any condition, which may please be noted. The payment shall be effected in name of your firm only.
- 3. Attendance:** You or your representative should be present at works site to receive the instructions / directions regarding the work.
- 4. Bank Charges:** Your Bank charges shall be at your account and our charges will be at our account.
- 5. Company's Property:** Proper care should be taken while working so that there will be no hindrances to any other work going in the plant, damage to the Company's property. Any loss on this account will be recovered from your bill or any of your dues with the Company.
- 6. Compensation:** No compensation claim for idle labour & Machinery for any reason will be entertained by the Company.

7. **Defect during Guarantee:** Any defect noticed during the guarantee period as specified, from the date of completion of work supply due to poor workmanship will have to be attended by the Contractor at his own cost and risk.
8. **Electricity & Water Supply :** Recovery shall be made towards water supply and electrical energy charges @ Rs. 0.50% and 0.25% respectively of the gross value of work done, if supply is given and as certified by the Engineer –in-charge.
9. **Enquiry Reference:** For any correspondence, reference of our enquiry should be invariably indicated.
10. **Enquiry Schedule Quantity:** Quantities mentioned in Schedule 'B' are approximate. Payment will be effected on the basis of the actual accepted measurements.
11. **Environmental Issues:** Contractor and his employee shall follow the current practices / procedure being implemented at Purchasers location as per ISO 14001-2004 and shall fulfill the environmental norms / requirements specified / latest issued by the State and Central Government.
12. **Gate Pass:** Contractor will have to prepare identification passes as per procedure laid down by security section for all the employees/workers entering in the power plant premises for the subject work.
13. **General Terms and Conditions:** The General terms and conditions for the tender of MAHAGENCO Ltd shall be applicable to this contract.
14. **Income Tax:** Income tax as per applicable ruling u/s. 194C of the Income Tax Act, 1961 along with surcharge & cess as applicable will be deducted from your gross bill while releasing payments.
15. **Jurisdiction:** All the disputes / differences will be under the Exclusive Jurisdiction of Court nearest to purchaser's location.
16. **Labour Competence:** In case labour/s found unsuitable, he / they should be removed from work site and suitable substitute must be arranged immediately.
17. **Miscellaneous work:** Any other miscellaneous work which is related to this work and not covered in the scope of work / schedule and becomes necessary to be carried out to complete the work, should be carried by you for which no extra payment will be made.
18. **Payment Term:** The payment shall be made by the office of Dy.CE(C), Civil Construction Circle, Koradi on submission of Bill/Tax invoice to the Executive Engineer(C), Civil Construction Unit-II, M.S.P.G.C.L., Koradi, through R.A. / final bill, after satisfactory completion of work through RTGS within 30 days from the date of receipt of bill subject to availability of fund. Mahagenco's MVAT No. should be mentioned in Tax Invoice. Mahagenco's **GST No. is 27AAECM2935RIZB.**
19. **PF Registration:** You shall have to fulfill all the formalities, statutory requirements of Employees Provident Fund and Misc. provision Act. -1952 & scheme framed there under and submit group insurance for manpower to be engaged.
20. **Rates:** The rates will remain firm throughout the contract period / completion period including extended period if any.


21. **Right to Cancel the Work:** The Company reserves the right to cancel the work order in part or full if the work quality, progress is found to be unsatisfactory. In such case the unexecuted work will be got completed through some another agency/ departmentally. For this extra expenditure if any incurred will be recovered along with 15 % supervision charges from any of yours dues with MAHAGENCO. Decision of the undersigned will be final and binding on you.
22. **RTGS Payment Term:** The payment shall be released through RTGS (Real Time Gross System) / NEFT (National Electronic Fund Transfer). To facilitate this, you will have to furnish Name of the Bank & Branch, Bank Account No. 15 digits, IFSC code 11 digits.
23. **Rules & Regulations :** Your staff will be governed by the relevant Rules, Regulations and Acts of State / central / Govt. in force, such as Workmen compensation Act, Minimum wages Act, Factory Act, Provident Fund Act, Labour Act etc.
24. **Safety Equipments :** You should provide safety equipments to the staff engaged for this contract. In case of accidents to you & your workmen, you will have to pay workmen compensation as per the Workmen's Compensation Act.
25. **Safety Regulation:** You have to follow safety regulation strictly and ensure precautions against any fire hazards while working. Contractor's authorized representative shall have to be present at works place to ensure safe working environment.
26. **Scaffolding:** All other material required for execution of work shall be arranged by you at your own cost.
27. **Scope of Work:** You have to carry out the work as per the Scope of work, terms and conditions mentioned / enclosed as per schedule - B.
28. **Security Deposit:** Security deposit @ 5% of the work order value i.e. **Rs. 1250.00 (Rs. One Thousand Two Hundred & Fifty Rupees Only)** shall have to be paid in the form of R.T.G.S / NEFT / Net Banking in the office of Dy. Chief Engineer (Civil), Civil Construction Circle, M.S.P.G.C.L., Koradi.
29. **Refund of Security Deposit :-** The Security Deposit shall be refunded to you after satisfactory completion of work and thereafter its maintenance period of **3 (Three) Months**. During the maintenance period you shall have to make good all the defects in the work, whatsoever, at no extra cost payable and to the entire satisfaction of the Engineer-in-charge for construction work. For maintenance work security deposit will be refunded after satisfactory completion of work also.
30. **GST :-** The GST and cess thereon shall be paid extra as per Prevailing provision of GST and amendments thereof.
31. **Rates quoted by you shall inclusive of:**
 - a) All tools & plants required for carrying out the jobs.
 - b) All labour charges required to execute the jobs.
 - c) All temporary works required to complete the work as directed.
 - d) All charges of loading, unloading, stacking, transportation, royalty of material used, taxes, duties, octroi, labour cesses etc. except service tax.
 - e) The work shall have to be carried out to meet the requirement of I.S.O. Standard. Company will not provide any T&P towards the completion of the work.
 - f) All material required for the work like cement, steel, structural steel etc shall be procured by you at your own cost

32. **Transportation:** All the transportation of material from the place of issue to the site of work and balance material/scrap back to the place as per the directives of MAHAGENCO authorities will have to be carried out by you at your own cost and risk.
33. **Work Satisfaction:** The work should be carried out as per the directives and up to the satisfaction of the undersigned or the Contract Operating Authority (COA) i.e. concern Executive Engineer(C).
34. **Schedule 'A' material:-** No material will be supplied by Mahagenco towards completion of this work.
35. **Acceptance of work order :-** Please acknowledge the receipt of this work order and convey your acceptance for the same within three days, failing which, it will be presumed that you have accept.
