13. Insurance Coverage:

If any accident/injury occurs to any other persons/public due to proven negligence/non-adherence to relevant safety and other precautions on the part of Contractor/it#s employees, the contractor shall emain liable to pay necessary compensation and other expense, as decided by appropriate authorities.

14. Quantity Variation:

The payment shall be made as per the Bill of Quantity and Billing Schedule, which shall be as per the actual quantum of work certified by us. In case of individual quantity variation being more than +10%, We shall have the right to negotiate for reduction in the unit rate which shall be mutually discussed and finalized. Any other variation of Individual quantity of work shall be done at same unit rate.

15. Price Validity for repeat order:

We and/or our Group company(ies) / Associated Company(ies)/ Sister Company(ies) / Holding Company(ies)/ Subsidary Company (ies)/ Business Associate(s) under our written authorization shall have the option to buy same set of equipment of any quantity on same price and commercial terms & conditions as that of this LOI within a period of 12 months from the Effective Date.

16. Confidential information:

You agree that any information received pursuant to this contract shall be treated as confidential information and shall not be disclosed to any third party except as is required by law or legal process.

17. Press Release / Public announcements:

You shall take prior written consent by providing draft well in advance for any kind of press release, public announcements or any other notifications with respect to this contract, for our approval under the provisions of law.

18. Wastage allowance for free issue material:

19. Governing Laws & Jurisdiction:

Any dispute arising out of or in connection with this contract, including any question regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration in accordance with the Arbitration Rules of the Mumbai Centre for International Arbitration ("MCIA Rules"), which rules are deemed to be incorporated by reference in this clause. The seat of Arbitration shall be Mumbai. Indian law shall govern this contract.

20. ADDITION / ALTERATION / MODIFICATION:

The owner reserves the right to make additions/ alterations/modifications to the quantity of the item in the purchase order. The Contractor shall supply such quantities also at the same rate as originally agreed to and incorporated in the Purchase Order.

21. Assignment & Subcontracting:

Seller shall not assign, in whole or in part, its rights and obligations under this Contract to any third party without prior written consent of the other Party. However, in case of assignment in favour of a subsidiary, holding company or group company such approval shall not be unreasonably withheld. The assignments of the Contract to Banks and/or export credit insurance agencies are permitted

22. TERMINATION OF CONTRACT:

JSW reserve the right to terminate this contract, in case vendor fails to give satisfactory service, after giving 15 days notice in writing. However, JSW will hold back all your equipment till alternate arrangements are made. The security deposit, however, shall be forfeited. In case you want to terminate the contract, you shall have to give 1 months notice in writing to the company.
